Policies

Deposit are non-refundable unless cancellation is submitted prior to 2 weeks before event.

Deposits are refundable if the facility/field is left clean and without damages and the key is returned. Deposits, if not refunded, are intended to cover the cost of re-keying a facility if a key is lost, and/or extra cleaning of the facility beyond normal use, if such is needed. If the cost of cleaning or damage repairs of any facility exceeds the deposit, the City reserves the right to charge the user for any additional costs incurred.

No park rental refunds will be granted due to inclement weather unless the pavilion/area is deemed unsafe or unusable.

Entire building may be rented if renter wants to make sure there are no distractions. The fee will be normal fee for upstairs and normal fee for downstairs.

Groups who are exclusively affiliated with the Hyde Park City community, in accordance with the boundary agreement, or its residents, or Hyde Park Chapters of an organization, may use the building free of charge. A deposit to cover damages may still be charged.

This would include, but not be limited to: Lions Club, Daughters of the Utah Pioneers, Scout Troops, charity benefits, quilters' guilds, etc. Reservation time should be during normal business hours, so that no lockup is required. If a paid reservation conflicts with a fee waived usage, the paying resident shall have priority.

Hyde Park residents may use the building for resident 80th Birthday Parties and 50th Wedding Anniversary parties free of charge.
